The regular meeting of Mayor and Council of the Borough of Buena was held September 30, 2024 commencing at 6:30 P.M. at the Borough Hall with Mayor Baruffi presiding. Mayor Baruffi announced that this meeting was being held in compliance with the Open Public Meetings Act and notices of this meeting have been provided, via email, to the Press of Atlantic City and the Daily Journal on November 27, 2023 as well as being posted on the bulletin board in Borough Hall.

MAYOR'S REPORT: First order of business

- Demolition is complete at 1005B Central Avenue, Minotola, known as the old Maurelli property.
- The Minotola Estates Buena Drive basin had been dropped to the proper height and swale was made. Waiting for as-built from Flanglier Engineering to review their paperwork.
- On September 30, 2024 met with Road Supervisor Nimohay, Administrator Coraluzzo, and perspective person to cut grass at Blackwater Pond Park. Administrator will provide the Borough solicitor a formal agreement to be taken into consideration at Council's October 15, 2024 meeting.
- Read into record correspondence sent September 23, 2024 from County Administrator DelRosso regarding drainage updates to Summer/Brewster Road and drainage issues at Route 40/Central Ave/Kimberly Lane.
- Read into record correspondence sent September 27, 2024 from NJDOT Regional Coordinator Sandra Opoku. Discussed a phone call with Ms. Opoku's assistant who clarified the five phases of the project to be as follows: 1) Problem screening is near complete. 2) Concept development phase anticipated to be complete by summer of 2025. 3) Primary engineering. 4) Final design. 5) Construction to begin in fall of 2027. It was noted that a project of this scope usually takes ten years to come to fruition.
- Read into record correspondence sent to Borough Engineer Marc DeBlasio from John Notte, Water Project Manager of New Jersey Infrastructure Bank regarding USDA joint project with Buena Borough Municipal Utilities Authority for Summer Road and West Ave.
- Congressman VanDrew's office is actively investigating resident's concerns regarding the spike in costs of their recent electric bills. Updates are posted to the Congressman's website to review the measures he has taken so far.
- Gerry Manganaro, Housing Program Director of USDA Rural Development, will provide an overview of housing programs through USDA Rural Development at the October 15, 2024 Workshop meeting.
- The First Annual Firefighter's Association will hold a roast beef sale on October 26, 2024 from 11 AM to 2 PM. Tickets are \$20.00 each and include two sandwiches, hot or sweet peppers, two bottles of water, and chips for pick-up at the Buena Borough fire department.

WHEREAS, N.J.S.A. 40A:65-1, et seq., known as the "Uniform Shared Services and Consolidation Act," authorizes two or more local units to enter into an agreement for shared services known as a Shared Services Agreement for the provision of municipal services ("Agreement."): and

WHEREAS, the governing body of the Borough of Buena recognizes that shared services may result in property tax relief and enhanced services for its residents and constituents; and

WHEREAS, the Borough engineer identified the need to replace the asbestos and clay tile sewer pipes on Summer Road; and

WHEREAS, The Borough of Buena and the Borough of Buena Municipal Utilities Authority wish to authorize DeBlasio & Associates to apply to the U.S. Department of Agriculture for funding under the USDA-RD- Preliminary Application for the replacement of asbestos and clay tile sewer pipes on Summer Road, in an amount not to exceed \$18,500.00, to replace various sanitary sewers; and

WHEREAS, The Borough of Buena and Borough of Buena Municipal Utilities Authority hereby endorses undertaking a shared services agreement for the provision of authorizing DeBlasio & Associates to apply to the U.S. Department of Agriculture for funding under the USDA-RD- Preliminary Application for said project in an amount not to exceed \$18,500.00, and the Authority paid at \$9,250.00 each; and

WHEREAS, the entities also agree that, if approved, all other mutually approved expenses incurred and not covered by the Grant will be paid at 50% by the Borough of Buena and 50% by the Borough of Buena Municipal Utilities Authority

NOW, THEREFORE, BE IT ORDAINED by Council of the Borough of Buena, County of Atlantic, State of New Jersey, as follows:

Section 1. Approval of Agreement. The Borough of Buena hereby approves the terms and conditions of a Shared Services Agreement for of the Borough of Buena Municipal Utilities Authority and the Borough of Buena and such Agreement attached hereto and incorporated herein by reference as Exhibit A dated September 16, 2024. The Mayor and Acting Clerk of the Borough of Buena are hereby expressly authorized to execute the aforesaid Agreement on behalf of the Borough.

Section 2. Miscellaneous.

- 1. <u>Amendment</u>. This Shared Services Agreement may not be amended or modified for any reason without the express prior written consent of the parties hereto.
- 2. <u>Successors and Assigns</u>. This Shared Services Agreement shall inure to the benefit of and shall be binding upon each other entity and their respective successors and assigns.
- **3.** <u>Severability</u>. In the event that any provision of this Shared Services Agreement shall be held to be invalid or unenforceable by any court of competent jurisdiction, such holding shall not invalidate or render unenforceable any other provision hereof.
- 4. <u>Counterparts</u>. This Shared Services Agreement may be simultaneously executed in several counterparts, each of which shall constitute an original document and all of which shall constitute but one and the same instrument.
- 5. <u>Entire Agreement</u>. This Shared Services Agreement sets forth all the promises, covenants, agreements, conditions and undertakings between the parties hereto with respect to the subject matter hereof, and supersedes all prior or contemporaneous agreements and undertakings, inducements, or conditions, express or implied, oral or written between the parties hereto.
- 6. **Further Assurances and Corrective Instruments.** Both entities shall execute, acknowledge and deliver, or cause to be executed, acknowledged and delivered, such supplements hereto and such further instruments as may reasonably be required for correcting any inadequate or incorrect description of the Project or to correct any inconsistent or ambiguous term hereof.
- 7. <u>Headings</u>. The Article and Section headings in this Shared Services Agreement are included herein for convenience of reference only and are not intended to define or limit the scope of any provision of this SharedServices Agreement.
- 8. <u>Non-Waiver</u>. It is understood and agreed that nothing which is contained in this Shared Services Agreement shall be construed as a waiver on the part of the parties, or any of them, of any right which is not explicitly waived in this Shared Services Agreement.
- **9.** <u>**Governing Law.**</u> The terms of this Shared Services Agreement shall be governed by and construed, interpreted and enforced in accordance with the laws of the State of New Jersey. Any legal action related to this agreement, or the performance thereof, shall only be filed in the Superior Court of New Jersey, Atlantic County, New Jersey.

WHEREAS, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled "Comments and Recommendations, as evidenced by the group affidavit form of the governing body attached hereto; and,

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and,

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52, to wit:

R.S. 52:27BB-52: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.
